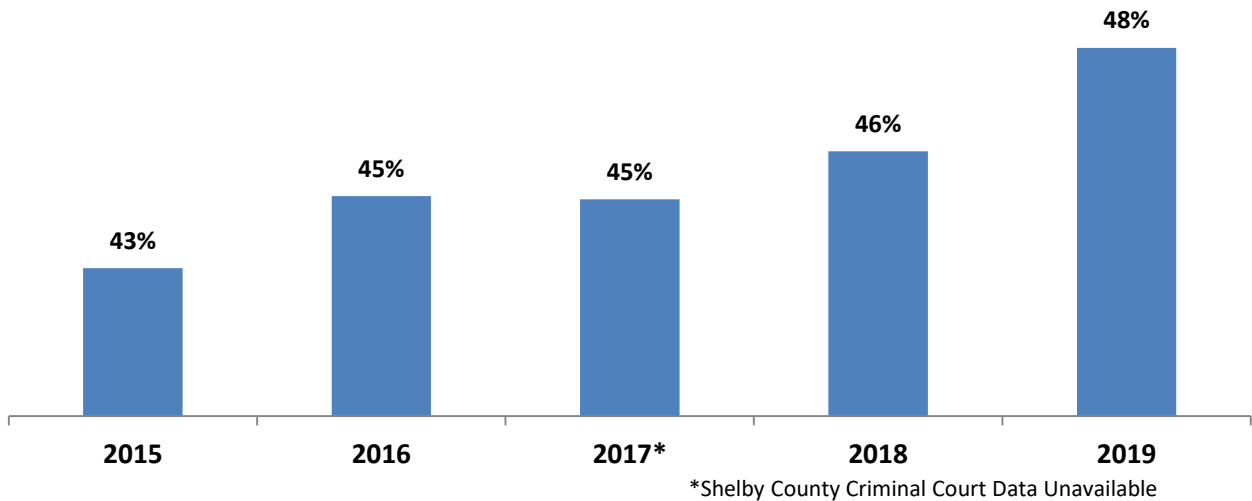

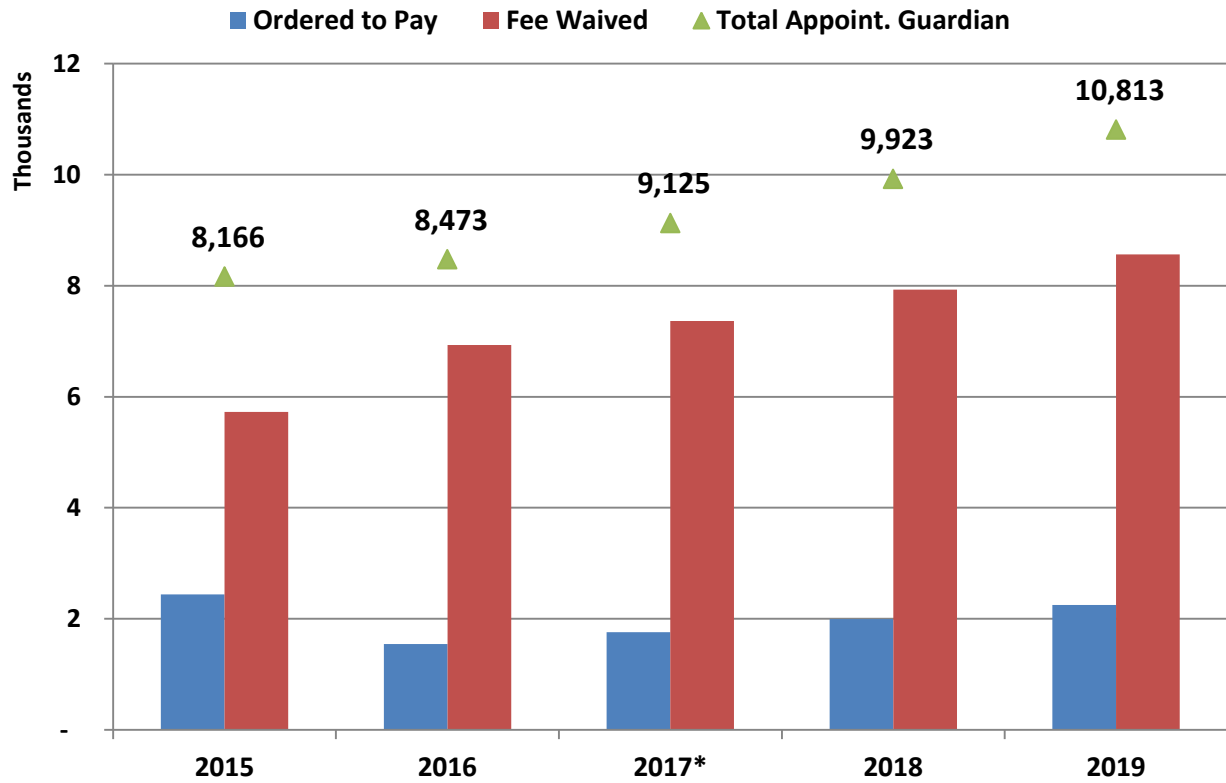
Number of Cases Defendants who were Appointed Counsel/ Public Defender or Private Attorney



Percentage of Cases Where Admin Fee was Waived

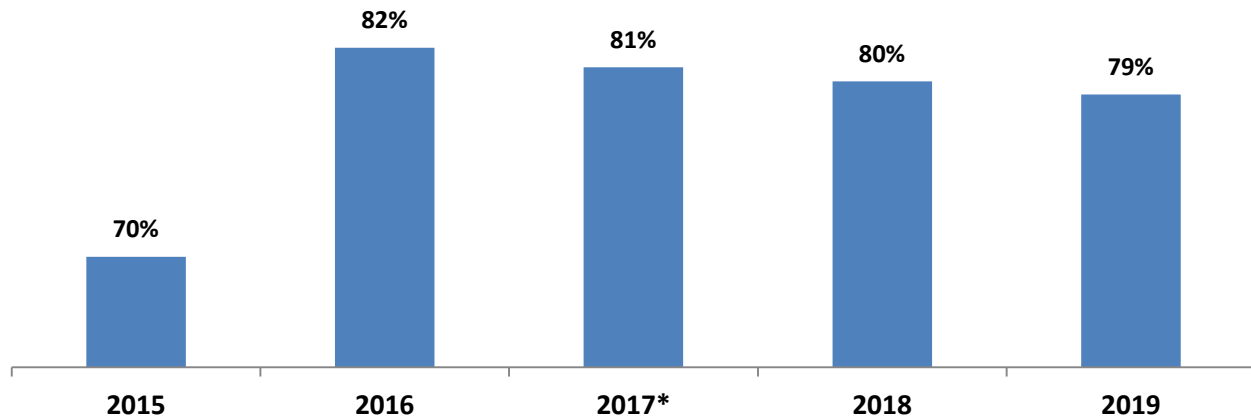


Number of Defendants Appointed a Guardian



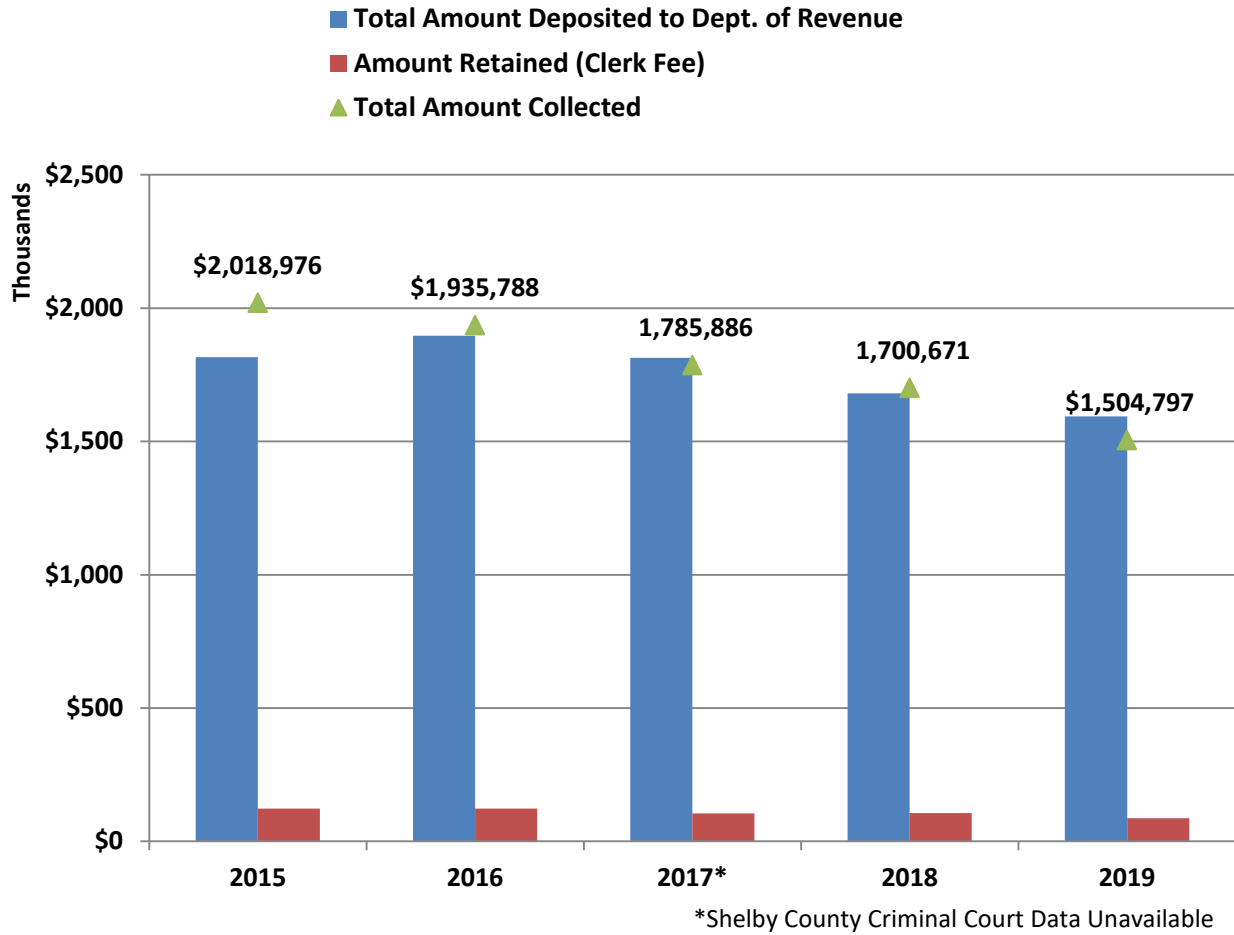
