There is provided by the 2010 General Appropriations Act, Chapter 1108 of the Public Acts of 2010, an appropriation for emergency and contingency for any purposes authorized by law for which no appropriation or for which inadvertently insufficient appropriation has been made, or for any public purpose within the implication of law for which no express appropriation is made.

1. There is sufficient balance in this appropriation, and expense of the following items should be provided therefrom:

From Code 353.00 Emergency and Contingency \$127,970.00

1. To Code 316.25 Tennessee Arts Commission \$76,650.00

I am directing the allotment of \$76,650.00 to provide funding for a grant(s) for remedial work on the Stieglitz Collection at Fisk University in Nashville, Tennessee. Any such grant awarded by the Commission shall be made contingent upon final approval, by January 15, 2015 by the Davidson County Chancery Court of *cy pres* relief sought by the Tennessee Attorney General in the case styled *In the matter of Fisk University*, No. 05-2994-III. If such relief is not approved by the court, the receiving entity(ies) shall return the grant(s) to the Commission, which shall in turn return the monies to the general fund.

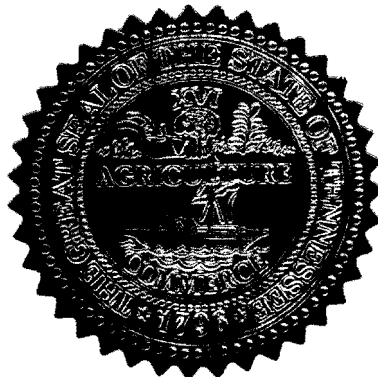
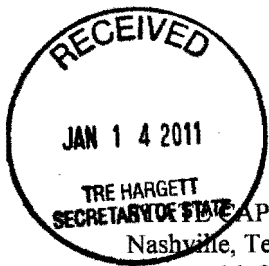
2. To Code 351.00 Miscellaneous Appropriations..... \$1,320.00

I am directing the allotment of \$1,320.00 to provide funding for a payment to the Department of Commerce and Insurance for plan reviews in connection with replacement of the Lighthouse Christian Academy school building destroyed by the May 2010 flood in Nashville, Tennessee (also known as Extreme Makeover Project 808).

3. To Code 351.00 Miscellaneous Appropriations..... \$50,000.00

I am directing payment of \$50,000.00 to the Dotson Special Needs Trust, established on behalf of Cedric Dotson (D.O.B. 11/1/2002), Cecil Dewayne Dotson, Jr. (D.O.B. 1/23/1999) and Cenyah Dotson (D.O.B. 12/31/2007) by order of the Probate Court of Shelby County on December 18, 2008, in satisfaction of a reward offered by the State of Tennessee in the "Lester Street" murders that occurred in Memphis, Tennessee, on March 3, 2008.

It is therefore ordered that a transfer be made out of said emergency and contingency appropriation to defray the expense of the previous items and that the Commissioner of Finance and Administration notify the Chief of Accounts to include the transfer in the work program allotment.
