Biographical information

George C. Browder obtained his bachelor's degree from Memphis State University and received a PhD from the University of Wisconsin-Madison in 1968. He taught history at the State University of New York at Fredonia until 2000. His original research and writing interests focused on comparative police and security agencies in modern industrial societies, but specifically those of Weimar and Nazi Germany. That led in turn to a focus on Holocaust perpetrators, Holocaust education, affiliation with the Holocaust Education Foundation, and collaboration with the United States Holocaust Memorial Museum. Browder's publications include *The Foundations of the Nazi Police State: The Formation of SIPO and SD* (The University Press of Kentucky, 1990) and *Hitler's Enforcers: The Gestapo and the SS Security Service in the Nazi Revolution*, (Oxford University Press, 1996).
