## Biographical information

Thomas Lee Crumbaugh was born on April 7, 1872 in Paducah, Kentucky, to George Chalmers (born 1838) and Alice Mills Crumbaugh. His siblings were John, Charles and Julia. Their mother died in 1874 and George married Evalin Parker (1842-1911) in 1875 and had four children: Alice P., George, Margery and Katie. Thomas married Frances Gibbs (May 2, 1872-October 2, 1949), the daughter of John Preston Gibbs and Elizabeth Bowers of Dresden, Tennessee, on May 8, 1892. The couple had four children: Lee Simmons (1894-1963); Frank Boyd (1897-1969), Robert Chalmers (1900-1961), and Alice Evelyn born in 1902. At the age of 20, Crumbaugh went to work for the Southern Express Company and became the company's youngest superintendent in 1909 based in Meridian, Mississippi. The company became part of the American Railway Express Company in 1918. Crumbaugh resigned his position to become sales manager of the Broadway Coal and Ice Company in Memphis, Tennessee, in 1919, and was soon appointed manager of the company. Thereafter, he lived at 2069 Harbert Avenue, Memphis. On July 16, 1931, he died of heart disease at his Memphis residence and was buried in Mt. Kenton Cemetery, Paducah.

Lee Simmons Crumbaugh, married Frances Jameson (1902-1995) in 1920 and they had a daughter, Frances Lee (born 1927). He worked as a traveling salesman for the Armour Soap Works and later for the Jefferson Island Salt Company. Frank Boyd Crumbaugh married Eleanor Bell Parker (1897-1976) in 1920 and they had a son, Frank B., Jr. (1927-1994). Frank, Jr. attended the University of Mississippi and married Jennie Sue Mayes in 1948 who was attending Texas State College for Women.

Robert Chalmers Crumbaugh attended the University of Mississippi for two years (1918-1920) and transferred at the beginning of his junior year to Vanderbilt University. He married Jane Louise Finnegan (1899-1988) in 1924 and they had two children: Jane Louise (1927-2017) and Robert C., Jr. (1929-1991). Alice Evelyn Crumbaugh attended Miss Hutchinson's School for Girls in Memphis and later married James Andrew Humphreys (born 1898). They had a son, James A., Jr. (born 1929).

## Scope and contents

The collection comprises the records of three generations of the Crumbaugh family. It includes personal correspondence, business and financial papers, publications and photographs and the papers are arranged by family member. The correspondence of Thomas Lee Crumbaugh and Lee Simmons Crumbaugh give insights into their business roles while that of Robert Chalmers Crumbaugh is predominately from young women while at college. The papers of other family members are mostly personal correspondence.

## Processing information

The collection was originally processed in 1978. Later additions were listed in 1984 and 1993 and some material was separated. In 2020, the collection was reorganized and the separated material reincorporated. The individual item information from the lists was retained in the inventory.
